EDITO

Created in 1996 on the CNRS campus in Orleans La Source, LE STUDIUM has evolved to become the multidisciplinary Loire Valley Institute for Advanced Studies (IAS), operating in the Centre-Val de Loire region of France. LE STUDIUM has its headquarters in the city centre of Orleans in a newly renovated 17th century building. The amazing facilities are shared with the University of Orleans. In 2014 new developments and programmes linked to the smart specialisation of the Centre-Val de Loire region came to strengthen existing IAS collaborative relationships with the local and the international community of researchers, developers and innovators.

LE STUDIUM IAS offers to internationally competitive senior research scientists the opportunity to discover and work in one of the IAS's affiliate laboratories from the University of Tours, the University of Orleans, National Institute of Applied Sciences (INSA) Centre Val de Loire and ESAD Orléans, as well as of nationally accredited research institutions located in the region Centre-Val de Loire (BRGM, CEA, CNRS, INSERM, INRAE). Our goal is to develop and nurture trans-disciplinary approaches as innovative tools for addressing some of the key scientific, socio-economic and cultural questions of the 21st century. We also encourage researchers' interactions with industry via the IAS's links with Poles of Competitiveness, Clusters, Technopoles, and Chambers of Commerce etc.

LE STUDIUM has attracted more than two hundred and eighty experienced researchers coming from 49 countries for long-term residencies. In addition to their contribution in their host laboratories, researchers participate in the scientific life of the IAS through attendance at monthly interdisciplinary meetings called LE STUDIUM THURSDAYS. Their presentations and debates enrich the regional scientific community at large (researchers of public and private laboratories, PhD students, research stakeholders' representatives, etc...)

For the period 2015-2021, LE STUDIUM has operated with an award from the European Commission, a programme supporting the mobility of international researchers, the Marie Skłodowska-Curie Actions (MSCA) COFUND programme.

For the period 2022-2025, LE STUDIUM has joined the FIAS Programme (French Institute for Advanced Study) along side six other institutes in France, also supported by the MSCA Actions. Since 2013, LE STUDIUM is also an official partner of the Ambition Research and Development programmes initiated by the Centre-Val de Loire Regional Council to support the smart specialisation strategy (S3) around priority domains: biopharmaceuticals, renewable energies, cosmetics, environmental metrology, digital twins, materials, forestry and natural and cultural heritage. Furthermore our current collaboration with the ATHENA European University Consortium allows us to welcome fellows from ten European partners universities. New programmes are currently designed to include all major societal challenges.

Researchers are invited and supported by the IAS to organise, during their residency and in collaboration with their host laboratory, a two-day LE STUDIUM CONFERENCE. It provides them with the opportunity to invite internationally renowned researchers to a cross-disciplinary conference, on a topical issue, to examine progress, discuss future studies and strategies to stimulate advances and practical applications in the chosen field. The invited participants are expected to attend for the duration of the conference and contribute to the intellectual exchange. Past experience has shown that these conditions facilitate the development or extension of existing collaborations and enable the creation of productive new research networks.

The present LE STUDIUM CONFERENCE named «(Not)available counselling actions in the migrant and refugee environment in France, Poland and Australia» is the 138th in a series started at the end of 2010 listed at the end of this booklet.

INTRODUCTION

This seminar is focused on the institutional availability, partial availability or the absence of practices, actions, counselling relations and other forms of support addressing refugees and migrants, as well as on the practices constructed nonformally by them (rooted in daily life). By comparing and demonstrating the specifics of international and transnational counselling and other forms of support, particularly in France, Poland and Australia, we will refer to those helping social actions that are initiated by migrants and refugees, and we will understand the meanings ascribed to these actions. We will answer questions such as, how these migrants and refugees evaluate these practices, what counselling and other helping networks they build, what changes take place in these networks, what is the counsellors' and helper's place in these networks and who they are.

WITH THE SUPPORT OF

The French Institutes for Advanced Study Fellowship Programme

The French Institutes for Advanced Study Programme* offers 10-month fellowships in the seven institutes of Loire Valley (Orléans-Tours), Lyon, Marseille, Montpellier, Nantes, Paris and Rennes. Initiated in 2020, the FIAS Fellowship programme will run until the 2024-2025 academic year. It welcomes applications from high-level international scholars and scientists wishing to develop their innovative research project in France.

The call is open to all disciplines in the social sciences and the humanities (SSH) and relating to all research fields. Research projects in other sciences and in arts that propose a strong interaction and dialogue with the SSH are eligible. Some host institutes have scientific priorities that need to be taken into full consideration before applying. At LE STUDIUM Loire Valley institute, interdisciplinary projects will be positively considered in the selection process.

Identically to all LE STUDIUM programmes, the FIAS Fellows are free to organise their research while benefiting from the support and conducive scientific environment offered by the institute characterised by a multidisciplinary cohort of fellows and by close relation to the local research centres and laboratories.

To be eligible, applicant researchers must be nationals or long-term residents of a country other than France and comply with the European mobility rules. For applications targeting LE STUDIUM, the preliminary acceptance into a host laboratory and/or host enterprise based in the Centre-Val de Loire region is necessary.

The annual call for applications opens every year in the month of April. Applications must be completed online on the FIAS website. Applications submitted by email will not be considered nor evaluated.

Kate Golebiowska, a Senior Research Fellow at Charles Darwin University, studies migrants' economic and social participation. Her work draws on migration studies, demography, human geography, entrepreneurship, and workforce development. Through peer-reviewed articles, reports and book chapters Kate has provided innovative insights into the effects of international migration on regional population dynamics and the strategies influencing migrant settlement and integration outcomes. As a Fulbright awardee at Emory University in Atlanta (spring 2023), she shadowed the Start:ME Accelerator and studied its impact on women microentrepreneurs from migrant and minority backgrounds. Additionally, Kate contributes to the field as the Vice-President of the Australian Population Association.

Institutional Support in Action: How Start:ME Micro-Business Accelerator Impacts Migrant and Minority Women Entrepreneurs in Atlanta, USA?

In this presentation, I share findings from research I conducted in 2023 with Start:ME, an accelerator program for micro-entrepreneurs from diverse and low-income areas in Atlanta delivered by Emory University and its community-based partners. Most participants in Start:ME are women with migrant and minority backgrounds. Through an analysis of formal and informal relationships within Start:ME, involving participants, volunteer business mentors, program management, and other supporters, I highlight how these connections complement the program's content. I discuss the pivotal role of these relationships in fostering micro-entrepreneurship among migrant and minority women and explain their enduring (though evolving) nature beyond the program's completion. Additionally, I delve into the meanings participants ascribe to institutional actions, the evaluation of these actions, and how they are positioned both as recipients of institutional support and agents in their own right. Through this analysis, I shed light on the expanded economic opportunities, enriched social capital and greater resilience experienced by women of migrant and minority backgrounds participating in Start:ME.

Migrations-refuges et résiliences : quels liens ?

Les migrations obligées font suite à des situations extrêmes laissant les personnes, au-delà des conditions d'accueil rencontrées dans le pays «refuge», en grande difficulté pour trouver à se reconstruire dans un environnement inconnu ou pouvant être ressenti comme hostile...

C'est là qu'on imagine la quasi nécessité, pour eux, de la mise en œuvre d'un processus de résilience, que certains souhaiteraient pouvoir les aider à activer.

Mais celui-ci ne se laisse pas commander et échappe à la volonté ou aux prévisions, il est également variable selon les personnes et leur façon de vivre les situations. Certaines, par exemple, présentent un esprit *nomade* et se sentent vite «chez elles» dans un lieu nouveau même non choisi, alors que d'autres, plutôt *sédentaires*, sont perdues dès qu'elles s'éloignent ; certaines sont dépendantes de leur environnement et de tout ce qui s'y produit, alors que d'autres sont moins perméables et peu affectées par ce qui les entoure. L'on peut donc concevoir que les modalités de résilience possible varient en fonction de telles caractéristiques, qui touchent à la vulnérabilité de chacun.

Nous présenterons ces diversités montrant combien il est important, pour tout contexte d'accueil, de tenir compte de la connaissance des personnes migrantes et de leurs spécificités, afin proposer un accompagnement optimal adapté à leur situation et besoins propres

Développer les approches anti-racistes en éducation et en formation: enjeux, outils, démarches

La Déclaration des Nations Unies et le Programme d'action de Durban de 2001 et 2009, visent à accentuer la lutte contre le racisme, les discriminations et la xénophobie tout comme les formes d'intolérance et de violences qui y sont associées. Le racisme a des conséquences multiples sur les plans économiques, psychologiques, sociales, culturelles, symboliques. Les discriminations entraînent rejet, agressivité, stress, exclusion, ressentiment... et affaiblissent l'estime de soi. Elles entravent le bien-être des enfants, des parents et des professionnels tout en affectant le climat des établissements éducatifs et scolaires. La reconnaissance des discriminations confirme la légitimité d'une prise en compte des stéréotypes et préjugés. Ceux-ci coexistent avec le néo-racisme et affectent les rapports sociaux dans les sociétés post-coloniales du Sud et du Nord. Les secteurs de l'éducation et de la formation font face à une demande croissante d'éduquer sans discriminer [Francis et al., 2018] qui se déploie selon de nouvelles perspectives. L'objectif de cette conférence est d'examiner les approches antiracistes en soulignant d'une part l'engagement progressif des institutions pour la diversité ethnoculturelle et, d'autre part, l'importance de la circulation des récits dans la lutte contre le racisme et pour la justice épistémique.

Anna deals with the analysis of career guidance and adult education. She analyses career guidance as a social process and phenomenon. Therefore, she is interested in the social role and prescriptions assigned to career guidance aimed at contributing to social justice, and social change. The latter one has directed Anna towards the issues of agency and activism analyzed from the perspective of life-long learning and critical pedagogy. Anna's three main areas of activity are:

- Policy-oriented consultations: Anna is a national alternate consultant in CEDEFOP
- The Research on career guidance – she conducted a few research related to comparative analyses of career guidance systems, meanings assigned to "social justice" by career guidance practitioners, theoretical studies related to the issue of agency, etc. She cooperates with Polish and international researchers in the field.
- The Research on lifelong learning and adult education – Anna conducted a few research projects related to social activism, and the multicultural local communities.

Career guidance for immigrants and refugees as the way to social inclusion. Current trends and challenges

In this presentation the analysis of the current trends and challenges within career guidance for immigrants will be presented. Career guidance here is understood as comprehensive, open, and flexible process that incorporates a variety of career development practices for enhancing immigrants' vocational wellbeing, e.g. career conversation, diagnosis, vocational rehabilitation etc. The author will focus on the main tasks and concepts related to career guidance for immigrants from the perspectives of policy, social inclusion and (not)available practices. The presentation covers issues related to challenges for career guidance for immigrants, e.g. cultural differences, language issues or – from broader perspectives – discrimination and exclusion from the labour market. While the central focus is on the immigrants' careers, this presentation keeps in mind that career always intertwines with the personal biographies and experiences of world. Some example of practices conducted in Poland will be provided.

Parcours de vie et ses tessitures : l'approche narrative et la construction des apprentissages expérientiels

Le but de cette communication est d'interroger l'intérêt de l'adoption de l'approche narrative dans la production des apprentissages expérientiels au cours d'un parcours de vie. Partant de la compréhension que le parcours de vie est un espace-temps qui prend forme au travers des expériences, invitant les individus à vivre des moments de changement, de réorientation, de transition, d'accélération, de décélération, de découvertes, de hésitations, de doutes, de certitudes, auxquels exercent des influences sur leur capacité d'agir et de réagir, la mise en mots de ces expériences devient un moyen et un support privilégié pour appréhender à la fois les expériences vécues et les apprentissages qui s'y dégagent.

Pour cela, il va falloir comprendre à la fois les régimes narratifs qui peuvent être mobilisés au cours d'un travail d'accompagnement de l'individu qui raconte son histoire et les relations qui s'établissent entre le vécu, sa mise en mots et l'identification des apprentissages expérientiels afin d'appréhender les tessitures qui se forment et qui donnent un contour, une forme, une expression à l'identité de l'individu.
